PROFILE

Alhassan Atta-Quayson is a Senior Lecturer at the Department of Economics Education, University of Education, Winneba, since 2013 and has previously worked with the Institute of Economic Affairs, International Food Policy Research Institute and Third World Network – Africa (TWN-A) among others. While at TWN-A, he coordinated the African Initiative on Mining, Environment and Society (AIMES), a pan-African grouping of policy makers, NGOs, academics and activists working on extractives, gaining access to a wide network of stakeholders in the extractives sector across the continent. He is a Research Fellow on extractives with the African Centre for Economic Transformation (ACET).

Alhassan Atta-Quayson has a long history of working on several extractives-related research and consultancy projects in Africa for organizations such as ACET, Economic Commission of Africa, TWN-A and Tax Justice Network – Africa, Natural Resource Governance Institute (through the Social Investment Consultancy), Action Aid International, Friedrich-Ebert-Stiftung Ghana (through Public Services International Ghana), IDRC (through WUSC), UNECA and AfDB, among others. He therefore possesses requisite understanding of the extractives sector focusing on key themes such as value addition, linkages, local content, artisanal and small-scale mining and fiscal regimes across the continent. He has vast experience and exceptional reach as far as stakeholder consultations and primary data collection are concerned. He has also consulted on other

research projects for institutions such as the UK-based Independent Commission for Aid Impact, Ghana-based Institute for Democratic Governance and some Municipal Assemblies in Ghana among others.

Over the two and a half year period that I worked with the TWN-Africa, I took charge of implementing the organization's three year programme on mining and development. The programme's broad objectives were defending Africa's policy options and space against further erosion by the aggressive promotion of aggressive transnational corporate rights. This included continued resistance to neo-liberal agendas being promoted by western governments, international financial institutions and donor agencies. The other main objective was the promotion of alternatives that address the systematic and structural constraints of Africa's economic development. The unit carved out four main advocacy issues with the following specific objectives:

- a. Environmental sustainability: resist practices which violate environmental standards and formulate and promote adoption of policies and norms/standards for protection of the environment.
- b. Community rights: resist practices which violate community rights and formulate and promote adoption of policies and norms/standards for protection of communities and their rights.
- c. Extractive sector and economic development: resist worsening imbalances in distribution of benefits of extractive sector among companies, national governments and communities. Formulate and promote policies which enhance economic benefits from extractive sector and their equitable distribution among stakeholders.
- d. Global financial and economic crisis: contribute to shape and raise visibility around the international debates for international action on issues and imbalances on international commodity trading regime, including commodity prices and price fluctuations, concentration of commodity trading, and long term secular decline of commodity prices.

The unit, in conformity with organizational standards, used the following intervention strategies in the attainment of the above objectives: lobby, public mobilization, communication and

information dissemination, research and knowledge generation, constituency building, networking and collaborative alliances and capacity building.

- ♣ Apr 2010 to Mar 2011 Research Officer, International Food Policy Res. Inst., Accra Over the one year period that I worked at the IFPRI I provided scientific and technical support to Senior Researchers and Fellows at the institute. My key duties and responsibilities associated with the position included the following:
 - Conducting literature reviews, including journal articles and policy documents;
 - Assisting with data collection, management and analysis;
 - Assisting in writing and editing project and research reports and other publications;
 - Maintaining the GSSP reference library;
 - Organizing and providing support for workshops and conferences;
 - Preparing presentations and presentation materials; and
 - Replying to requests for literature and information.
- Dec 2009 to Apr 2010 Field Officer, International Food Policy Research Inst., Accra I was recruited on a consultancy basis to assist in the collection of data for the execution of a research project on "Transforming Agriculture: The Case of Tomato in Ghana." The main objective in developing the case on tomato was to demonstrate the need for cost-reducing technical change in successful transformation of agriculture in a competitive environment and to examine options for public interventions to facilitate the development. The case developed information on the sector that are necessary to demonstrate the relevance of issues such as processes that lead to technical change, coordination failures, regional integration, institutions to strengthen research extension linkages, value chain analysis, the development of innovations systems, and the role of state in provision of public goods and in overcoming market failures in general.

In this regard I was stationed at Bolgatanga, the capital of Upper East Region, where I coordinated real time data collection and detailed agronomic and other surveys, between December 2009 and April 2010, through the tomato season. The purpose of the surveys was to identify the key drivers of tomato yields and tomato quality. The survey also aimed at testing hypotheses such as the importance of agronomic conditions, including soil quality and soil-borne pathogens; and the importance of water management. The approach included taking soil samples at the start of the survey and when the tomatoes are harvested; measuring plot size accurately; and testing the quality of the fruit harvested. One hundred farmers in ten communities were selected for the case.

Nov to Dec 2009 - Assistant Researcher – Institute for Democratic Governance, Accra I was engaged as a member of a 3-man Research Team commissioned to carry out a study into the Government of Ghana's proposed reform of the county's Decentralization Policy. The main objective of the study was to identify key policy issues arising from debate and public consultations organized by the government to inform a critical analysis leading to an appraisal of the logical coherence, relevance, and efficacy of the proposals and options. I had personal interviews with civil servants and key Politicians within the local governance system in Greater

Accra and Volta Regions. We produced a report on the study and a position paper on Ghana's Decentralization Policy.

- Nov 2009 Research Assistant International Food Policy Research Institute, Accra I was recruited to assist in data collection on changes in the organization of cocoa farming at the farm level, especially the organization of labour within the context of wider changes in the cocoa economy, and changes in the livelihoods of people involved in cocoa production. The main interest was to evaluate the impact of changes in farming households involved in cocoa production, on their direct involvement in cocoa farm production today; their dependence on hired labour, as well as their ability to access available labour; and their uptake of new technology including their interest in and ability to replant old trees. In this regard, I assisted the Principal Investigator to undertake an 8-day village survey aimed at appraising the issues, in Brong Ahafo and Western Regions of Ghana.
- Oct to Nov 2009 Field Assistant International Food Policy Research Institute, Accra I was engaged to join a team of four to undertake a 3-week survey on tomato production in nine communities in Greater Accra, Brong Ahafo, and Upper East Regions of Ghana. The purpose of the study was to have an appraisal of the tomato industry in Ghana. Nine communities were selected from three regions well-known for tomato production in the country. Together with other Officers, we administered 116 questionnaires, 19 of them were administered on purposively selected farmers who are either award winners or noted farmers in the selected communities. Focus-group discussions were also organized from time to time to clarify issues and get consensus on identifiable technologies used by farmers in the communities covered in the survey.
- Aug to Oct 2009 Research Assistant Institute for Democratic Governance, Accra I was employed as Research Assistant on a research project titled "Comparative Study on the Development and Use of Governance Indicators in Africa". I was assigned to the case on Parliament Civil Society Interaction: How Civil Society Influenced the Mining and Minerals Law and the Representation of the Peoples Amended Law. In this regard, I conducted a desktop study on the case and collected data in the form of interviewing Members and High-ranking Officials of Parliament. I also interviewed officials of key Civil Society Organizations. I analyzed the gathered information, and together with the desk-top study, prepared a report. The project was co-funded by the UNDP and IDASA, in South Africa. I worked in a team of seven researchers.
- ♣ Feb to Jul 2009 Consulting Facilitator African Inst. For Management Studies, Accra I have been regularly consulted, over the period, to facilitate management training courses at the Institute.
